- Get your medications delivered to your door within 4 hours after a consultation (subject to consultation date & time and courier service arrangement)

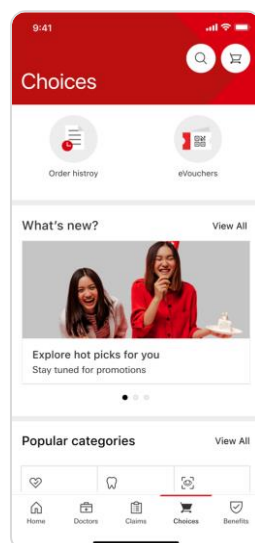

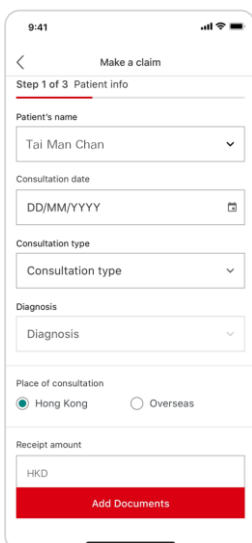
- Upload the prescription image and provide the original prescription to collect your medications with ease

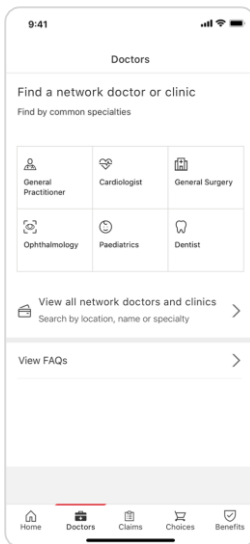

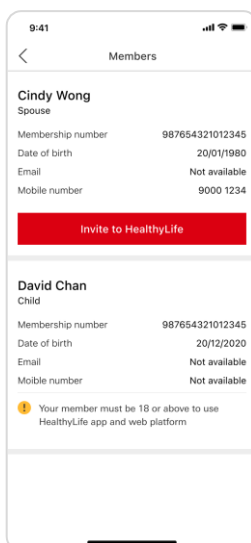

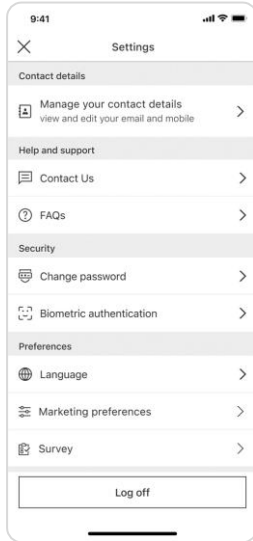
## Use of eHealth Card
